COPE's Mission:

Religious rights in public schools



Q. What is a religious issue?

A. An issue that deals with an ultimate question; *i.e.*, Where did we come from? What is the nature and purpose of life? How should I live morally and ethically?

Q. How should public schools deal with subjects touching on religious issues?

A. When such subjects are taught, disclose the religious issue and present the subject in an objective manner so that the effect of the teaching will be religiously neutral.

Q. What does "religion" include?

A. Religion is an activity that profoundly relates the life of man to the world in which he lives. U.S. courts have ruled that religion includes theistic, atheistic, and pantheistic belief systems.

Q. What topics deal with religious issues?

These include, among others, the origin, development, and nature of life and the universe; the sanctity of life; family and marriage; human sexuality; morality and ethics; and religion in culture and history.

Q. Does COPE support school choice?

COPE believes that parents should be free to choose among public, private, and home school options for their children. Control by parents and local school boards is best.

Next Generation Science Standards



Q. Why is COPE concerned about NGSS?

A. NGSS addresses religious questions, but provides only materialistic (atheistic) answers. This violates the religious neutrality principle in the First Amendment.

Q. What topics are of most concern?

A. Origins science (origin/development of life and the universe) and environmentalism (climate change, sustainable development).

Q. Does NGSS contain evidence for or consideration of teleology (design or purpose in nature)?

A. No. NGSS uses methodological naturalism, an arbitrary doctrine that restricts science to materialistic explanations.

Q. What is COPE doing to combat NGSS?

In September, 2013 COPE filed suit in federal court against the Kansas State Board of Education, alleging that NGSS has the effect of establishing an atheistic/materialistic worldview.

Q. Is NGSS related to Common Core?

A. NGSS science is designed to "align" and "cohere" with Common Core mathematics and English language arts standards. COPE is opposed to these and any other "national" standards that detract from local control.
